DEVIATIONS AND EXCEPTIONS:	All proposals must include a detailed statement of exceptions taken to any part of the request. Deviations or exceptions stipulated in a Vendor’s response will be considered during the contract evaluation where IDEA CNP reserves the right to accept or reject a proposal based on any submitted deviation. A deviation will not be effective unless accepted by IDEA CNP. IDEA CNP may, in its sole discretion, seek clarification from and/or communicate with Proposer(s) regarding any submitted deviation, consistent with general procurement principles of fair competition. Any language to the effect that the Vendor does not consider this RFP to be part of a contractual obligation may result in the Vendor’s proposal being disqualified. In the absence of any deviation(s) identified and described in accordance with above, Vendor must fully comply with the Terms and Conditions, Proposal Specifications, and all other requirements associated with this bidsolicitation.
ESTIMATED COST:	Approximately \$200,000 - \$500,000 depending on the number of sites that are selected to receive the service. The estimated cost or value of this Proposal should not be construed to be a guarantee of either a minimum or maximum usage. Once proposals are received the District will determine the quantity of campuses and locations that will pilot this service.
