Executive Director Reports:

- 1. Ken shared the success of IDEA Cortana's groundbreaking on September 5th. Grateful for the partnerships and excited that Tom, JoAnn were able to take part of the event.
- 2. The land swap regarding the Innovation Drive campus is to close today. Plan to break ground the 1st week of October. Loans should be closed within a few weeks.
- 3. Tanyatta Mayo, a Teacher Fellow, located at the N. Mission College Prep in the RGV was awarded Employee of the Month.
- 4. This week the Teacher Fellow and PIR Quarterly is taken place this week in the RGV.
- 5. Spoke with Michael, William and Lakeisha regarding Chloe Wiley, Principal of Bridge Academy. Documents will be sent out to the Board within a few weeks regarding merging of Bridge with IDEA.
- 6. Also, there was an article in the Paper regarding a Principal and Laurel Oaks (a charter school supported by NSBR) arrested allegedly for locking a student in a closet. Please note that this school has no barren on us and this school is a Type 2 Charter meaning that it was recommended by the State and not by EBRPS Board.
- Ken also shared news regarding the IDEA National Board Retreat held in San Antonio this weekend. Five boards members attended; two from Baton Rouge and three from New Orleans. Pastor Mary Moss and Theodore Richards travelled and gave their thoughts and viewpoints regarding the retreat.
