Action Item A: Budget Amendment

The proposed budget amendment recognizes \$41,131.47 in revenue and expenses. The budget amendment will allow for the early hiring of a Child Nutrition Program (CNP) regional manager, regional nurse and health aides for IDEA Hope and IDEA Victory.

IDEA Hope Academy; Emily Carlisle, IDEA Hope College Preparatory; Latoya McGhee, IDEA Victory Academy; and Dr. Kendrah Underwood, IDEA Victory College Preparatory, to serve as Principals. Each of these four exceptional leaders has extensive experience in K-12 education and has a proven track record in raising student achievement. Each of the four participated in IDEA's Principal-in-Residence Program, receiving up to two years of intensive and targeted training, coaching and guidance.

Ms. Robinson indicated that Teach For America (TFA) is a national leader in recruiting, selecting, training and providing ongoing professional development to individuals committed to closing the achievement gap by serving as effective classroom teachers, coaches, and school leaders specifically equipped to enhance student achievement in under-resourced school systems.

The resolution provides that when the IDEA Florida Board has voted to approve contracts or agreements, or has approved purchases by adopting the approved annual budget, thereby approving purchases authorized in the approved budget, Julene Robinson, Executive Director of IDEA Tampa Bay and Jose Luis De Leon, Executive Director of IDEA Jacksonville, are authorized to sign and execute on behalf of the IDEA FL Board, except for contracts where IPS Enterprises, Inc. or IDEA Public Schools-Texas is a party to the contract or agreement.

Action Item F: Community Foundation PRI Loan

Chair Gonzalez-Reynolds introduced the item and Jazmin Leon-Wing presented the item. To better support a successful and timely launch of two IDEA Jacksonville school sites, IDEA Florida applied for a short-term low-interest Program Related Investment Loan from the Community Foundation of Northeast Florida. The resolution will authorize IDEA Florida to transfer the proceeds of the loan to IPS Enterprises, Inc. where the funding will help cover certain due diligence and soft costs that are not eligible expenditures under our existing grant funding sources. The resolution further states to the extent all or a portion of the loan proceeds transferred to IPS Enterprises are used for costs related to the two charter school facilities that are typically capitalized when the facilities are financed, at the time of the financing, the proceeds of the facility financing will either be used to pay down the loan to the extent of capitalized costs, or, if the normally capitalized costs funded by the loan proceeds are not part of the financing, there will be a reduction in the overall amount of the facility leases with IDEA Florida Inc. in the amount of the normally capitalized costs, to reflect the prior IDEA Florida Inc. payment of costs for those two properties

Action Item G: Office Depot Purchase Agreement Revision

Chair Gonzalez-Reynolds introduced the item and Mr. Elliott Nguyen presented the item. During the February 2021 Board Meeting, the IDEA Florida Board of Directors approved an advanced

purchase of \$374,130 for furniture for IDEA Hope and Victory (Action Item H, February 12, 2021). Additional needs have been identified, including cafeteria tables, fireproof filing cabinets for the purposes of student records. Additional smaller costs associated with separated “AR” zones for College Prep students contributed to the overall cost increase. We are requesting an amendment to the original approval for an additional \$159,616.70 for a total of \$532,746.70.

Action Item H: Purchase of School Buses and White Fleet Vehicles

Chair Gonzalez-Reynolds introduced the item and Raul Banda presented the item. Request approval to initiate and complete the procurement of school buses and white fleet vehicles on behalf of IDEA Florida not to exceed \$1,550,000. The procurement will include four white fleet vehicles and up to twelve (12) school busses necessary for the 2021-22 school year. All vehicles will meet Florida specifications and requirements and programmatic needs. School busses will be procured through Florida Transportation Systems, Inc. The Vendor was selected via a Request for Proposal procurement (RFP #22-RFP-TRN-2021). The Vendor for the white fleet vehicles has not yet been selected. Staff will complete price comparisons to ensure that IDEA Florida receives competitive pricing and the highest value.
