1. **Cover Page:** Page one of this package shall be filled out and signed by an authorized company representative.
2. **Profile and Experience:** Vendor shall include background information on company and key employees involved in the execution of goods and services outlined in their proposal.
3. **Costs and Additional Fees:** Vendor shall include item costs and any additional fees not expressly stated or requested in this RFP, including one-time fees that may be charged.
4. **References:** Vendor shall provide two verifiable references either using the form attached or through alternative form for other entities similar to IDEA Public Schools for which the Vendor has provided goods and/or services.
5. **Certificate of Insurance:** Vendor shall provide proof of Workers' Compensation, General Liability, and Fidelity Bonding insurance.
6. **Criminal History Review of Vendor Employees:** Vendor shall review and complete the attached form regarding "Covered Employees" and criminal history and/or fingerprinting records.
7. **Debarment or Suspension Certificate:** Vendor shall review and complete the attached form.
8. **Conflicts Disclosure Statement (CIQ):** Vendor shall provide a signed and completed copy of the attached Form CIQ.
9. **State of Texas Health and Human Services Commission- Child Support Certification:** Vendor shall review and complete the attached form required when utilizing state funding.

RFP Proposal Submissions

Proposals should be prepared in such a way as to demonstrate a straightforward, concise delineation of capabilities that satisfy the requirements of the RFP. To be eligible for consideration, electronically locked proposals should be received via [Tyler Munis](#) or by mail to the IDEA Public Schools Headquarters no later than **5:00 PM CST on February 3, 2022**, along with the requisite signature pages and completed certification forms. Proposals sent by mail must be in a sealed envelope marked with the **RFP Number and Title** and include:

- One (1) clearly identified hard copy ORIGINAL of the Proposal response.
- One (1) copy of the proposal on a FLASH DRIVE, marked with Vendor's name.

RFP Proposal Opening

Proposal Opening is scheduled for **February 3, 2022, at 5 pm (CST)**. A formal "opening" will not be held. Trade secrets and confidential information contained in proposals shall not generally be open for public inspection, but IDEA's records are a matter of public record. A submitted proposal constitutes an offer to perform work and/or deliver the products specified in the proposal solicitation.

GENERAL INFORMATION

IDEA prepares students from underserved communities for success in college and citizenship. We are a growing network of 137 high-performing charter schools serving approximately 78,000 students located throughout Texas, Louisiana and Florida. IDEA plans to expand to Jacksonville, FL and Cincinnati, OH in 2022, and to Arkansas in 2023. Although IDEA's growth is rapid, it is also well planned and carefully calculated. Schools begin with minimal grade levels, adding facilities as students advance and eventually reaching full scale as a Pre-K - 12 campus.

The mission of IDEA is College for All. IDEA serves primarily low-income students in underserved areas of both rural and urban communities. Over 85% of IDEA students are considered low - income and one of every three students is the first in their family to go to college. Since our first graduating class in 2007, 100% of our seniors have been accepted and matriculated to a college or university every year for fourteen consecutive years. Thanks to a rigorous path to college that begins in Pre-K, IDEA students attend selective universities throughout the country, win national awards and scholarships, and complete college at a rate six times the national average for low-income students.

RFP Purpose

IDEA Public Schools and affiliated entities (IDEA) is currently seeking vendors to serve as authorized providers of student uniforms for one or any combination of the regions we serve. The authorized vendors will supply uniform polo shirts and a lightweight jacket. The authorized vendors may be eligible to provide other IDEA-branded items with approval from IDEA including school spirit tees, belts and backpacks, scarves and beanies. Vendors should be prepared to service families by providing retail locations and/or a website where families can purchase items.

IDEA is accepting proposals from organizations that are qualified and have experience in supplying student uniforms for Texas, Louisiana, Florida, and Ohio.

IDEA reserves the right to revise and amend the specifications prior to the date set for the receipt of proposals. Respondents are requested to clarify any ambiguity, conflict, discrepancy, omission or other error(s) in the RFP in writing. Revisions or amendments, if any, will be made by issuing an addendum. Every effort will be made to send addenda issued to the parties known to have been furnished a complete copy of the RFP. It is the responsibility of each Vendor, prior to submitting the Proposal, to contact IDEA to determine if addenda were issued and, if so, to obtain such addenda for attachment to the Proposal.

Project Description and Scope of Services

IDEA Public Schools is seeking vendors to provide student uniforms for the schools listed below starting in the 2022-2023 school year. The student uniforms would need to be available for families to purchase no later than June 1, 2022.

Successful vendors will bear the responsibility of managing all relationships with IDEA families and collecting any and all payments and handling any returns, product quality control and customer satisfaction with IDEA families. At no time will IDEA be responsible for the payment of items not expressly authorized in writing by IDEA staff who are authorized by IDEA to place orders. IDEA will provide families with the contact information of the authorized student uniform providers throughout the district. IDEA will develop the appropriate protocols to help assist in setting uniform expectations that are clearly communicated to families.

The projected enrollment for IDEA Public Schools in 2022-2023 and 2023-2024 is below. A more detailed projection can be found in Appendix A and Appendix B. These projections are not a guarantee of business. Vendors should use the detailed projections to forecast student uniform production for a respective region or combination of regions. The average number of polos purchased per student is 3.5 and light-weight jackets per student is 1.5.

RFP Performance Requirements

A prospective vendor will provide the following:

Desired Services

The selected vendor(s) will be responsible for supplying student uniform polo shirts and light-weight jackets of a specific design and construction in youth and adult sizes. Vendors who are unable to supply uniform polo shirts and light-weight jackets may not be considered for additional items (T-shirts, other IDEA-branded items, etc.). The vendor(s) shall be responsible for all aspects of the uniform process, including but not limited to: forecasting, manufacturing, transporting, selling, and distributing uniform items. In addition, the vendors shall be responsible for resolving any issues related to quality control, customer service and/or the collection of funds.

Vendors should be prepared to serve families in a single region or any combination of the following regions:

1. Rio Grande Valley, Texas
2. San Antonio, Texas
3. Austin, Texas
4. El Paso, Texas
5. Tarrant County, Texas
6. Houston, Texas
7. Midland/Odessa, Texas
8. Baton Rouge, Louisiana
9. Tampa Bay, Florida
10. Jacksonville, Florida
11. Cincinnati, Ohio

A contract or licensing agreement for student uniforms may be executed for each entity listed in this solicitation with successful vendor(s) as a result of this process, and the successful vendor(s) agree(s) that fulfillment of the award under this RFP is conditioned on agreement to and compliance with the terms of this RFP and any subsequent written agreement or contract.

IDEA Public Schools Responsibility

IDEA will negotiate an agreement for authorized student uniform vendors on behalf of IDEA families. IDEA Public Schools, at its sole discretion, reserves the right to renew the contract annually based on the vendor's performance under the contract and current needs of IDEA families. Authorized vendors must meet quality control and other standards required by IDEA for all products marketed to IDEA families or ordered by IDEA.

Quality Assurance

Prospective vendors will enter into a license agreement with IDEA Public Schools to serve as an authorized provider of student uniforms.

Who is Eligible to Respond?

Vendors who are able to meet the specifications for quality and other terms of this proposal, and who are not debarred and/or suspended from conducting business with federal and state funded agencies are invited to respond. A prospective vendor must affirmatively demonstrate the vendor's responsibility. A prospective vendor, by submitting a proposal, represents to IDEA Public Schools that it meets the following requirements:

- Ability to obtain adequate financial resources as required to perform under this RFP
- Ability to comply with the required or proposed RFP
- Have a satisfactory record of integrity and ethics.

Contract Term

The term for this contract will be from June 1, 2022 – July 31, 2023, with an option of continuation for an additional year at the discretion of IDEA Public Schools.

Right to Additional Competition

IDEA Public Schools occasionally solicits qualifications or bids for services, and expressly reserves the right to enter into one or more license agreements for any goods and/or services described in this request, at any time, if deemed to be in the best interest of IDEA Public Schools.

PROPOSAL EVALUATION

Evaluation Criteria

Proposals will be evaluated on criteria deemed to be in the best interest of IDEA families and include, but are not limited to:

General: Ability to meet required and desired specifications, including terms and conditions.

Pricing: Vendors agree to provide items at pre-negotiated prices to IDEA families based on best overall value; prices will remain stable throughout the course of any agreement without any increase in price without the approval of IDEA Public Schools. Vendors who can provide incentive programs to encourage early buying, discounts, rebates, and/or free items should describe these programs in the proposal. Vendors should keep in mind that over 85% of IDEA students are low-income. IDEA expects to receive very competitive pricing and favorable terms to serve these families.

Inventory Risk Management: Vendors will provide a thorough and robust forecast of all uniform garments the vendor intends to provide using baseline data provided by IDEA. This forecast will include all sizes and colors and comply with the specific colors and designs designated by IDEA. Vendors agree to bear the burden of any start-up costs affiliated to this project, including but not limited to: the planning, production, transportation, and distribution of uniform garments, the addition of storage facilities or storefronts, the training of staff and personnel, or investment in equipment or technology. The responsibility of ordering, supplying, sorting, and distributing uniform components will be borne solely by vendor. It is recommended that vendors outline all processes from design phase through production. Vendors may be required to provide samples of a size run and color run, upon request by IDEA.

Distribution and Logistics: Vendors agree to serve all schools in the region(s) where they have been selected as a preferred vendor. Vendors who are able to provide in-person sales and customer service should include this in the proposal. Vendor should list shipping and Curbside pickup availability. All locations should be equipped to begin selling and distributing orders by June 1st, 2022.

Customer Service: Vendor(s) shall serve as primary provider of customer service to IDEA families. Vendor employees should provide expedient, courteous, and high-quality customer service while maintaining a clean and organized environment conducive to an excellent customer experience. Vendors should expect to receive unannounced visits from IDEA employees to evaluate the overall level of service being provided at any storefront location. Vendors will have bilingual staff to serve IDEA families in applicable regions. Customers should be served through a variety of mediums including, but not limited to a retail store, an online store, on the phone, and through e-mail. Vendors should have curbside and shipping options available. Customers should have a basic expectation for a typical response time from the vendor. Vendor(s) should also consider options for layaway and payment plans, as well as a variety of payment methods to best support IDEA families. Itemized receipts should be provided to all families. Vendors should be prepared to accept exchanges based on size or fit, as well as returns for damaged items. Returns should be accommodated up to 30 days after the first day of school.

Experience and References, and Past Relationships: The relative weights for scoring are provided below; the evaluation team will consider the following elements in the evaluation process. Ability to meet acceptable purchase prices will not be the only factor considered in the selection process.

RANKING CRITERIA POINTS (Total 100 points)

1. Cost/Price: Keep costs for IDEA families as low as possible; additional consideration will be given for rebates, discount programs, payment plans, and/or free uniforms. (40 points)
2. Inventory Management: Forecast, manufacture, supply, and provide uniform garments starting June 1 and throughout the school year. (20 points)

 - f. Crimes occurring wholly or in part on school property or at a school-sponsored activity; and
 - g. Felonies involving driving while intoxicated.
2. A felony offense under Title 5, Penal Code.
3. An offense or conviction for which a defendant is required to register as a sex offender.
4. An offense under the laws of another state or federal law that is equivalent to an offense under items (2) and (3) above where, at the time the offense occurred, the victim of the offense was under 18 years of age or was enrolled in a public school.
5. Any other offense that IDEA Public Schools believes might compromise the safety of students, staff, or property.

Any Vendor interested in participating in IDEA Public Schools selection process must comply with the requirements of Texas Education Code § 22.0834 by working with IDEA Public Schools to conduct fingerprint checks on employees prior to being awarded a contract. 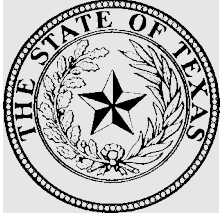
