#### **1.GENERAL & BACKGROUND INFORMATION**

IDEA Public Schools ("IDEA") is a Texas nonprofit corporation and a tax-exempt organization pursuant to the Section 501(c)(3) of the Internal Revenue Code. Pursuant to Chapter 12, Subchapter D of the Texas Education Code and its Contract for Charter with the Texas State Board of Education, as renewed by the Commissioner of Education, IDEA is an open-enrollment charter holder, governmental entity and public school system. IDEA prepares Texas students from underserved communities for success in college and citizenship. IDEA is a growing network of 123 high-performing charter schools serving approximately 67,988 students located throughout Texas in the Austin, El Paso, Houston, Permian Basin, Rio Grande Valley, San Antonio, and Tarrant County regions. Although IDEA's growth is rapid, it is also carefully planned. Schools begin with select grade levels and eventually reach full scale as a Pre-K-12 campus as grade levels are added to accommodate the students' advancement.

IDEA's mission is College for All. IDEA serves primarily low-income students in underserved areas of both rural and urban communities. Over 80% of IDEA students are considered low-income and one of every three students is the first in their family to go to college. Since the first graduating class in 2007, 100% of seniors have been accepted and matriculated to a college or university every year for fourteen consecutive years. Thanks to a rigorous path to college that begins in Pre-K, IDEA students attend selective universities throughout the country, win national awards and scholarships, and complete college at a rate six times the national average for low-income students.

# Note: While IDEA's affiliates serve students in other states, this Request for Proposals and any subsequent contract is only for goods or services provided to IDEA's Texas based charter school and campuses.

#### 2.GENERAL INTENT

IDEA is soliciting an Invitation for Bids (IFB) for <u>maintenance of IDEA UIL soccer fields</u> for forty-two (42) of our Texas Campuses identified in "Attachment L".

Each vendor shall furnish the information required in the bid package. The vendor shall <u>sign first page of this bid</u> <u>and all addenda(s) (if issued</u>). The person signing the proposal <u>must initial</u> at the bottom of every page, erasures, and/or other changes. Bids signed by an agent must be accompanied by evidence of the agent's authority unless such evidence has been previously furnished to IDEA. The result of this IFB solicitation is a <u>one (1) year term</u> upon board approval with the option to extend <u>two (2) additional one (1) year terms</u>.

- a. Deliveries shall be Freight on board (FOB) Destination to IDEA destination sites. Freight is prepaid and assumed by the vendor. IDEA reserves the right to pick up items in lieu of delivery from local vendors.
- b. IDEA does not pay Federal Excise Taxes. Tax exemption certificates will be provided upon request.
- c. The vendor may offer an "equal" product or product exceeding specifications as an alternate proposal. Final determination of whether an item is an "approved equal" remains with IDEA.
- d. Bids submitted on forms other than the IDEA forms or with different terms or provisions may be considered as non-responsive proposals.
- e. All bids shall remain firm for a term of 120 days after IFB solicitation period is closed.
- f. The vendor shall certify that no federal or state suspension or debarment is in place, which would preclude receiving a state or federally funded award.

#### **3.RESERVATIONS**

IDEA expressly reserves the right to:

a. Waive minor deviations from the specifications when it is determined that the total cost to the IDEA of the deviating proposal is lower than the lowest conforming proposal which meets all aspects of the specifications, and the overall function of the goods or services, or both, specified in the deviating proposal is equal to or greater than that of the conforming proposal.

#### 5.NOTICE TO ALL VENDORS

- a. Vendor shall keep IDEA advised of any changes in order(s) status.
- b. All submittals are to be for the <u>maintenance of IDEA UIL soccer fields</u> as indicated in the bid item list located in Attachment L of this IFB. Pricing should include freight/shipping costs and any other fees that apply as indicated by IDEA.



- c. IDEA encourages HUB vendor participation, if vendor is a state certified HUB vendor (Historically Underutilized Business) and/ or certified MWBD vendor (Minority and Women-owned Business), certification must be included in submittal.
- d. All pricing and any award under this IFB shall be available for all IDEA departments and divisions and any other entity purchasing through IDEA.
- e. The selected respondent(s) will follow practices, processes, and protocols established by local, state, and federal agencies with respect to their field of service and goods.
- f. All bids will be screened for inclusion of all required information prior to release to the evaluation team. IDEA staff may exclude from further consideration for contract award any non-responsive proposal or portion of a proposal.

#### 6.QUALIFICATIONS & EQUIPMENT

IDEA expectations with respect to the performance by each vendor in connection with the purchases are set out in the "Contract Documents" which consist of the Invitation for Bids ("IFB"), Instructions to Vendors, Standard Terms and Conditions, and Bid Sheet. Vendors who fail to examine the Contract Documents do so at their own risk.

- A. The bid item list and specifications that follow are specific requirements. Any deviation or comparable product must be properly identified and be accepted by IDEA Public Schools through individual submittals of <u>Attachment "K</u>" included in this IFB packet, one for each deviation. Any deviation to specifications must be listed and clearly defined.
- B. Scope of work including equipment specifications will be listed in <u>Attachment "L"</u>. For this reason, vendors are discouraged from describing any deviations simply as "equal" or "exceeds" the defined requirements: Instead, vendors are strongly encouraged to explain all deviations in the template provided. Failure to do so may result in the rejection of the bid and or product for non-compliance.

#### 1. Qualifications

- a. All bidders must have a principal person with a Major or equivalent experience in Horticulture or Turfgrass Science. **Resumes must be provided.**
- b. The business must have a lead position to direct the work crews. The principal or lead person must have a minimum education of 2-year associates in turfgrass with a 3 or more years' experience directing and maintaining an Athletic turfgrass maintenance operation.
- c. Acceptable experience would be equivalent to Superintendent of turfgrass at a golf course or on athletic fields.
- d. This person or persons must have references.
- e. Bidders/companies are preferred to have experience at schools on soccer, baseball, or football fields.
- f. Please include references for the bidding company.
- g. The principal or the lead person must be licensed and able to perform all fertilizer & IPM chemical concentration/application calculations and be able to manage the complete program. They must be able to identify the pests, weeds and fungus for our region that are associated with the athletic fields.
- h. The Principal or lead must be documented at the site at least once per week and the Lead person must have real time knowledge of the crew activities.

#### 2. Equipment

- a. All mowing equipment must be in good condition. Please include pictures.
- b. The following is an equipment list of the minimum equipment required:
  - Quantity of two (2) John Deere Model 2653B Precision Cut Trim and Surrounds Reel Mowers or <u>equivalent</u>. All mowers will be Diesel powered Reel Mowers. Need to have a minimum of two (2) mowers described above. <u>Rotary mowers are not acceptable.</u>
  - ii. Quantity of one (1) John Deere 2030A 300- or 200-gallon mechanical broadcast boom sprayer. On a Diesel Utility Vehicle.



- iii. Quantity of one (1) Gator Utility type vehicle
- iv. Quantity of one (1) Mechanical Topdresser
- v. Quantity of one (1) Lely or Vicon type fertilizer spreader. <u>Push spreaders are not</u> <u>acceptable.</u>
- vi. Quantity of one (1) mechanical type verti-cutter or dethatcher
- vii. Quantity of one (1) Pull behind Jet Blower
- viii. Quantity of one (1) mechanical type aerifier
- ix. Must have safe, reliable, and professional looking trucks and trailers. No smoking engines. No noticeable rust.
- 3. All Employees must have appropriate work attire and personal protective equipment (PPE)
- 4. The successful bidder must develop a complete Insecticide and Fungicide program, or Integrated Pest Management (IPM) program based on need or prevention. \*<u>Please include a section describing your experience with Integrated Pest Management and what</u> you project will be needed. Please include optional costs.

### 6.SCOPE OF WORK

#### **IDEA UIL Soccer Field Maintenance**

The Awarded Vendor(s) Contractor(s) shall, at Contractor's expense, furnish in a diligent and workmanlike manner all supervisory personnel, labor, equipment, machinery, tools, materials, and supplies necessary for the performance of the work and services contemplated herein. Contractor shall not employ in any Work for Company any employee whose employment violates applicable labor laws. All materials, equipment, supplies, and manufactured articles furnished by Contractor in the performance of the Work shall be fit for their intended use, shall be free from Defects, and shall be of the best quality for their respective purposes unless otherwise specified in writing by Company. All Work shall be in accordance with all applicable safety regulations, precautions, and procedures in the industry and shall employ all necessary and desirable protective equipment and devices. Any breach of this safety covenant by or on behalf of Contractor shall be grounds for immediate termination of this Contract by Company which shall be effective upon notice from Company to Contractor.

IDEA Public Schools in Texas is looking for a qualified vendor to provide **UIL Soccer Field Maintenance** for the following Texas regions: Upper RGV, Lower RGV, San Antonio, Austin, El Paso, Tarrant County, and Houston. The Campus names and addresses can be found in **Attachment L.** This bid will be based on the price per field and awarded by region.

#### UIL Field Size



Each field is approximately 1.5 acres (65,340 square feet). If a field is more than 1.5 acres and if it is agreed to by IDEA, the price can be adjusted with a price per sq. ft multiplier. Bidders must submit the price per field and price per sq. ft.



The selected vendor shall provide the following services but not limited to:

#### A. Mowing of UIL Fields

- All UIL fields will be mowed once per week with the reel type mower specified in the Equipment section.

#### B. Take Soil Samples

 Vendor shall take soil samples from each field. The fertilization program will be partially based on this fertilization. It will also be based on the grass needs and activities required by the school. For example, a liquid fertilizer application may be requested to prepare for a School event or additional fertilizer may be required to prepare the grass for the playing season.

#### C. Fertilization of Fields

- Fertilization shall be performed at least 10x per year. Each event will have at least 1 lb. of N or more per 1000 sq. ft.
- Fertilizer shall also have appropriate amounts of P, K and other elements based on the soil samples and the needs of the plants.

#### \*Please attach a strategy on this in the bid package.

 The above listed fertilizer spreader (Lely or Vicon type fertilizer spreader) or sprayer (John Deere 2030A 300- or 200-gallon mechanical broadcast boom sprayer on a diesel utility vehicle) will be used to apply the fertilizer to ensure even application. (See Section 6.2 Equipment)

#### D. Weed Control

- Weed control shall be maintained at a high level of expectation. No weeds should grow to a flowering or seed production phase.
- To prevent the establishment of weeds, four (4) pre-emergent type herbicide applications shall be scheduled and applied strategically. <u>Please provide a proposed schedule.</u>
- Vendor shall use follow up selective herbicides to reduce and minimize populations.
- Vendor shall monitor very difficult weeds to include but not limited to weeds in the Nutsedge family or Goose Grass family. Vendor shall keep populations shall under control.

#### E. Water Management Program

- As part of the water management program, irrigation times shall be adjusted and malfunctioned spray heads and equipment shall be identified. Bidder must have the ability to coordinate with coaches and administration, develop a wetting agent program to conserve water, and possess good working knowledge of the irrigation system and equipment used on IDEA campuses.
- The entire field will be top dressed with a mixture of 80% sand and 20% organic matter annually. Equipment listed above in Section 2: Equipment will be used to obtain an even application. The applicator or successful bidder will ensure the sand is evenly applied. This is to ensure the ball rolls smoothly.
- All fields will be aerified and verti-cut at least once per year. The above listed equipment shall be used.

#### F. Overseeding Schedule

- <u>Please provide a plan for overseeding schedule</u> to include a 3-way perennial Ryegrass at 15-20 lbs. per 1000 sq. ft.
- The edges shall be finished with a drop spreader and a rotary type spreader will be used for the remainder of the field. A hydroseeder may be used at the same rate of 15-20 lbs. per 1000 sq. ft.



\*Quality shall be measured with a semi-annual assessment form that will be submitted to the school representative. The grass should be growing on 90% of the field that did not require renovation or has been renovated. It should have a satisfactory green color.

#### **8.WHO IS ELIGIBLE TO RESPOND**

Respondents who are eligible to meet the technical specifications for quality and other terms of this bid package, and who are not debarred and/or suspended from conducting business with district, federal and state funded agencies and are recognized by the Texas Comptroller of Public Accounts as having an "Active" right to transact business in Texas are invited to respond. A prospective respondent must affirmatively demonstrate respondent's responsibility. A prospective respondent, by submitting a bid, represents to IDEA that it meets the following requirements:

- a. Possesses or can obtain adequate financial resources as required to perform under this IFB
- b. Respondent shall comply with the requirements proposed in this IFB
- c. Have a satisfactory record of integrity and ethics
- d. Respondent shall be in good standing with all applicable national or state associations

#### 9.RESPONSIVE/RESPONSIBLE RESPONDENTS

IDEA staff reviews the bids received to determine if they are responsive. For bids to be considered responsive and to be evaluated for selection, the following requirements must be met:

- 1. The bids must have been submitted by the due date and time.
- 2. The bids must be complete with the original signatures in blue ink.
- 3. The bids must be for the specific services requested and described in the IFB Packet.
- 4. The bids must be submitted in the format described in the IFB Packet.
- 5. One original (in blue ink and marked original) and one copies must be submitted.
- 6. Electronic format on a USB flash drive. The electronic version shall be one file that replicates your original proposal including required signatures. NOTE: Do not send individual files of each section or page of your proposal as the electronic version.

#### 7. Attachment L shall be completed and submitted as a separate document with your bid response.

#### **10.PROCUREMENT CONDITIONS/ GENERAL TERMS**

Procurement of the items under this IFB shall be in accordance with the IDEA Public Schools Purchasing Policy<sup>1</sup> and the terms and conditions set forth in this section and shall form a part of the contract documents and purchase order for goods and/or services included in this IFB:

- 1. IDEA is utilizing the Invitation for Bid (IFB) method of procurement in accordance with the Code of Federal Regulations, 2 CFR § 200.320(b)(1).
- The listed bid items are commonly acquired items and prices will be used to determine best value, with the selection of the successful bidder made principally on the basis of price, as set forth at 2 CFR § 200.320(b)(1)(i)(C).
- 3. In accordance with 2 CFR § 200.320(b)(1)(ii)(D), a firm fixed price contract will be awarded to the lowest responsive and responsible bidder(s).
- 4. Warranty and all other pertinent documentation shall be included for each vehicle.

- 5. All bids must include a detailed statement of exceptions taken to any part of the request. Any deviations from this procurement solicitation must be noted on the deviations and exceptions form. Deviations or exceptions stipulated in a Vendor's response may result in disqualification. Any language to the effect that the Vendor does not consider this IFB to be part of a contractual obligation may result in the Vendor's proposal being disqualified. In the absence of any deviation(s) identified and described in accordance with above, Vendor must fully comply with the Terms and Conditions, Proposal Specifications, and all other requirements associated with this bid solicitation. Every deviation from the bid items requested must have its own individual Exception or Deviation template located in Attachment "K".
- 6. IDEA assumes no financial responsibility for any costs incurred by prospective vendors in developing and submitting a bid or any amendments or addenda, participating in pre-bid conferences, interviews, participating in any negotiation sessions or discussions, or any other costs incurred by vendors prior to award of a Contract/Agreement pursuant to this IFB.
- 7. Deliveries under this Agreement shall be freight prepaid, Freight on Board (FOB) destination, Full Freight Allowed, Inside Delivery and shall be included in all pricing in Vendors proposal unless otherwise clearly stated in writing in Vendor's proposal. IDEA assumes no liability for goods delivered in damaged or unacceptable condition. The successful bidder will handle all claims with carriers, and in case of damaged goods, will ship replacement goods immediately upon notification by IDEA of damage. Bid prices will include all freight and delivery charges.
- 8. Deliveries shall be made between 6:30 AM and 2:00 PM, at the designated IDEA campus, unless prior approval for after-hours delivery has been obtained form IDEA. Inspection will be done by IDEA staff at the moment of delivery of item(s). Key drop deliveries are not allowed without the full approval of IDEA and such request must be identified in the Deviations and Exceptions Form "Attachment K".
- 9. Vendor and/or sales agents acting on the Vendors behalf, shall give 72-hour prior notice to the IDEA of any anticipated disruption of services or delivery of products.
- 10. All prices in Vendor's proposal should remain firm for the Term of the Agreement. Any price changes shall be presented to IDEA, for acceptance or rejection by IDEA, in its sole discretion, using the same format as was accepted in Vendor's original bid; all price changes for goods and/or services provided under this Agreement, must be approved, in writing, by IDEA prior to taking effect. The following documentation shall be provided to support a request for price change: justification for change/increase using a known market index/market condition, terms and conditions, and/or manufacturers/distributors' impact (if any).

- n. Do not include Federal Excise, State or City Sales Tax. IDEA shall furnish exemption certificate, if required.
- o. If a credit is due, the next/subsequent invoice must show the credit owed and applied.
- p. If IDEA denies or rejects a product deemed unacceptable, IDEA staff will make a notation directly on the invoice, initial and date it, along with the initials of the delivery driver.
- 13. IDEA may during term of award add additional campuses/delivery locations to be included as part of the agreement resulting from this IFB solicitation.
- 14. If the Vendor's/manufacturer's warranty is less than the required period, the Vendor shall warrant the goods and/or services to the full extent as provided by the Vendor/manufacturer. THE CONTRACTOR FURTHER ACKNOWLEDGES, STIPULATES, AND AGREES THAT NOTHING IN THIS RFQ AND/OR IN ANY RESULTING CONTRACT WITH IDEA SHALL BE CONSTRUED AS A WAIVER OF

#### CERTIFICATION REGARDING WORK HOURS AND SAFETY STANDARDS

Contract Work Hours and Safety Standards Act (40 U.S.C. 3701-3708). Where applicable, all contracts awarded by the non-Federal entity in excess of \$100,000 that involve the employment of mechanics or laborers must include a provision for compliance with 40 U.S.C. 3702 and 3704, as supplemented by Department of Labor regulations (29 CFR Part 5). - The United States Department of Agriculture shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2) of this section.

When required by Federal program legislation, all prime construction contracts in D. excess of \$2,000 awarded by School must include a provision for compliance with the Davis-Bacon Act (40 U.S.C. 3141–3144, and 3146–3148) as supplemented by Department of Labor regulations (29 CFR 5, "Labor Standards Provisions Applicable to Contracts Covering Federally Financed and Assisted Construction"). In accordance with the statute, contractors must be required to pay wages to laborers and mechanics at a rate not less than the prevailing wages specified in a wage determination made by the Secretary of Labor. In addition, contractors must be required to pay wages not less than once a week. School must place a copy of the current prevailing wage determination issued by the Department of Labor in each solicitation. The decision to award a contract or subcontract must be conditioned upon the acceptance of the wage determination. School must report all suspected or reported violations to the Federal awarding agency. The contracts must also include a provision for compliance with the Copeland "Anti-Kickback" Act (40 U.S.C. 3145), as supplemented by Department of Labor regulations (29 CFR 3, "Contractors and Subcontractors on Public Building or Public Work Financed in Whole or in Part by Loans or Grants from the United States"). The Act provides that each contractor or subrecipient must be prohibited from inducing, by any means, any person employed in the construction, completion, or repair of public work, to give up any part of the compensation to which he or she is otherwise entitled. The School must report all suspected or reported violations to the Federal awarding agency.
- E. <u>Contract Work Hours and Safety Standards Act</u>. Where applicable, all contracts awarded by School in excess of \$100,000 that involve the employment of mechanics or laborers must include a provision for compliance with 40 U.S.C. 3702 and 3704, as supplemented by Department of Labor Rev. 03/22/2023



regulations (29 CFR 5). Under 40 U.S.C. 3702 of the Act, each contractor must be required to compute the wages of every mechanic and laborer on the basis of a standard work week of 40 hours. Work in excess of the standard work week is permissible provided that the worker is compensated at a rate of not less than one and a half times the basic rate of pay for all hours worked in excess of 40 hours in the work week. The requirements of 40 U.S.C. 3704 are applicable to construction work and provide that no laborer or mechanic must be required to work in surroundings or under working conditions which are unsanitary, hazardous or dangerous. These requirements do not apply to the purchases of supplies or materials or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.

- F. <u>Rights to Inventions Made Under a Contract or Agreement</u>. If the Federal award meets the definition of "funding agreement" under 37 CFR 401.2 (a) and the recipient or subrecipient wishes to enter into a contract with a small business firm or nonprofit organization regarding the substitution of parties, assignment or performance of experimental, developmental, or research work under that "funding agreement," the recipient or subrecipient must comply with the requirements of 37 CFR 401, "Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any implementing regulations issued by the awarding agency.
- G. <u>Clean Air Act and the Federal Water Pollution Control Act</u>. Contracts and subgrants of amounts in excess of \$150,000 must contain a provision that requires the contractor to agree to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act (42 U.S.C. 7401–7671q) and the Federal Water Pollution Control Act as amended (33 U.S.C. 1251–1387). Violations must be reported to the Federal awarding agency and the Regional Office of the Environmental Protection Agency (EPA).
- H. <u>Energy Efficiency Standards and Policies</u>. Mandatory standards and policies relating to energy efficiency which are contained in the state energy conservation plan issued in compliance with the Energy Policy and Conservation Act (42 U.S.C. 6201).
- I. <u>Debarment and Suspension</u>. A contract award (see 2 CFR 180.220) must not be made to parties listed on the governmentwide Excluded Parties List System in the System for Award Management (SAM), in accordance with the OMB guidelines at 2 CFR 180 that implement Executive Orders 12549 (3 CFR Part 1986 Comp., p. 189) and 12689 (3 CFR Part 1989 Comp., p. 235), "Debarment and Suspension." The Excluded Parties List System in SAM contains the names of parties debarred, suspended, or otherwise excluded by agencies, as well as parties declared ineligible under statutory or regulatory authority other than Executive Order 12549.
- J. <u>Byrd Anti-Lobbying</u>. Contractors that apply or bid for an award of \$100,000 or more must file the required certification. Each tier certifies to the tier above that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any Federal contract, grant or any other award covered by 31 U.S.C. 1352. Each tier must also disclose any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award. Such disclosures are forwarded from tier to tier.
- K. <u>Procurement of Recovered Materials</u>. School and its contractors must comply with section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act. The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 CFR 247 that contain the highest percentage of



recovered materials practicable, consistent with maintaining a satisfactory level of competition, where the purchase price of the item exceeds \$10,000 or the value of the quantity acquired by the preceding fiscal year exceeded \$10,000; procuring solid waste management services in a manner that maximizes energy and resource recovery; and establishing an affirmative procurement program for procurement of recovered materials identified in the EPA guidelines.
