Revenue

- Average state revenue across ISDs is a combination of local property tax revenue and state funds
 - The blend between local maintenance & operations and state funding is relative to the property tax collections as a function of property values and tax rates
- Charters have no local property tax revenues and majority funded by the state
 - 76% of IDEA's revenue in 2021-22 was state aid
- Charters are also not able to generate I&S tax revenue and do not benefit from state assistance for debt service in contrast to ISDs
 - Charters do continue to benefit from facilities funding, but that amount is capped and will continue to lower on a per student basis as the charter population grows
 - IDEA received \$10.2MM in facilities funding in 2021-22, \$180 per student

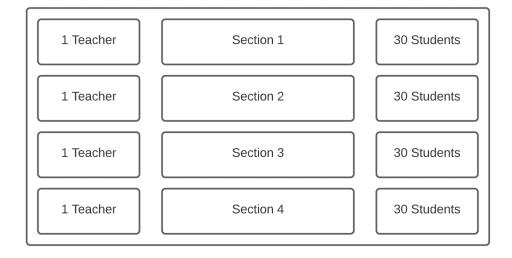

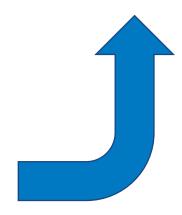

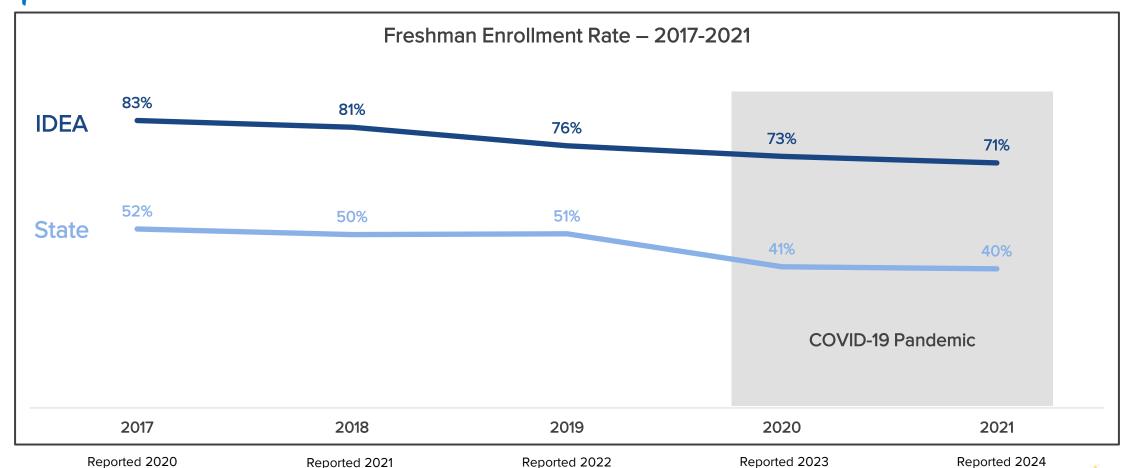

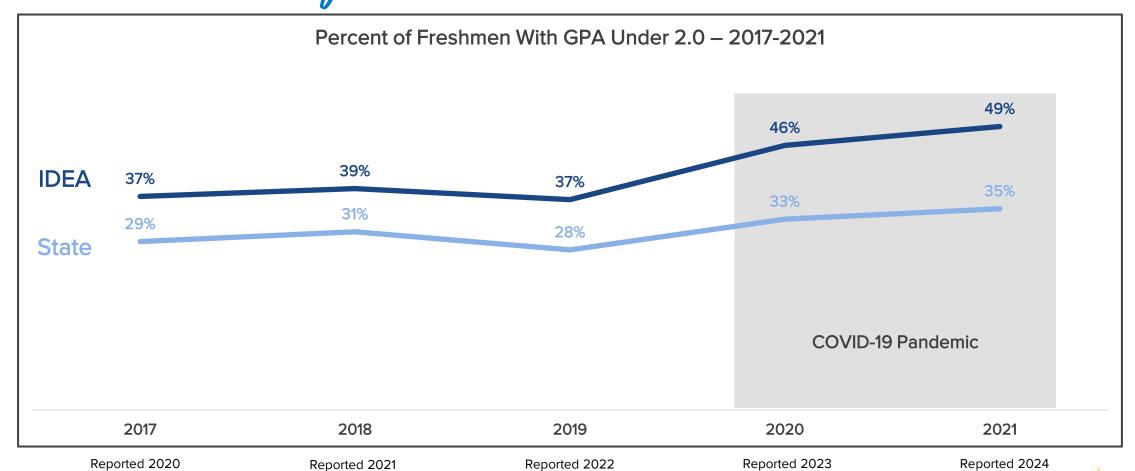

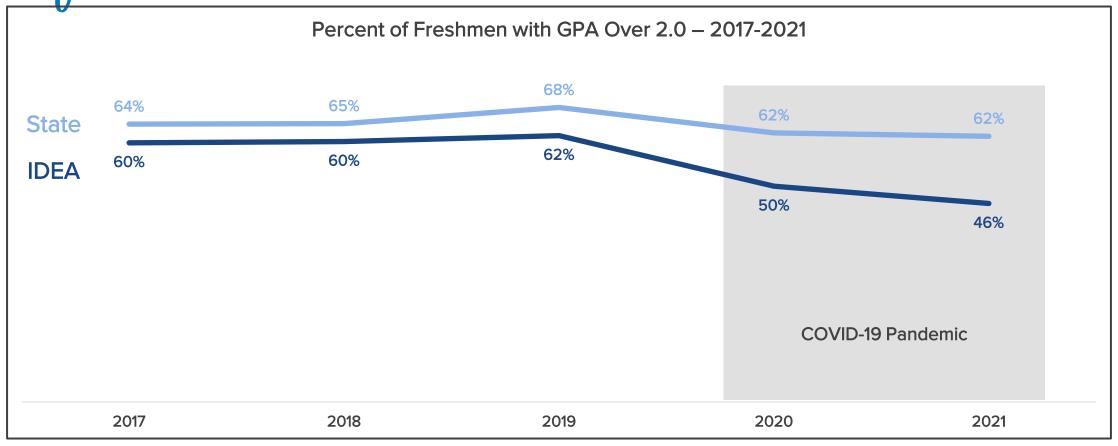

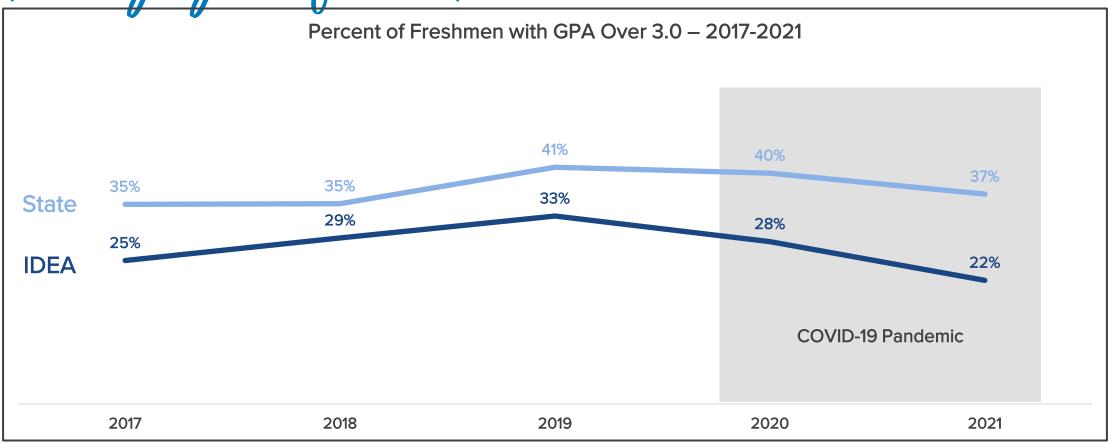

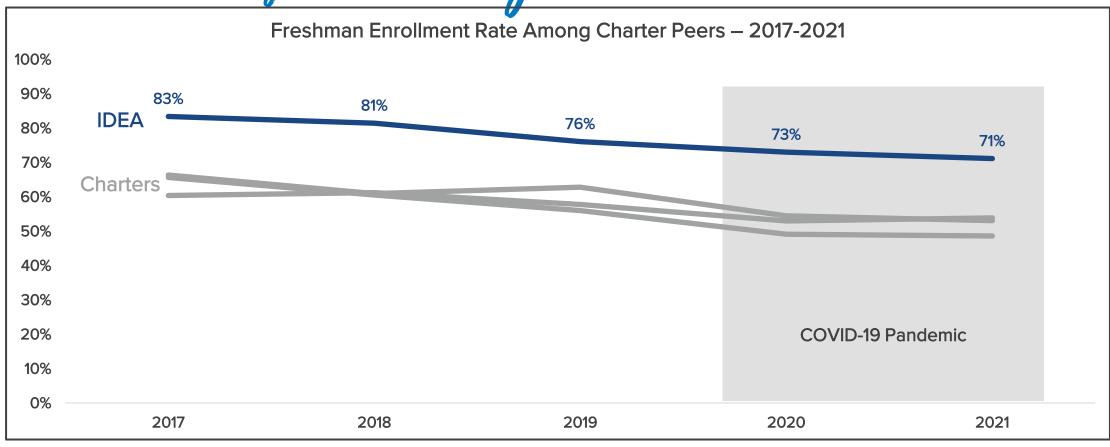

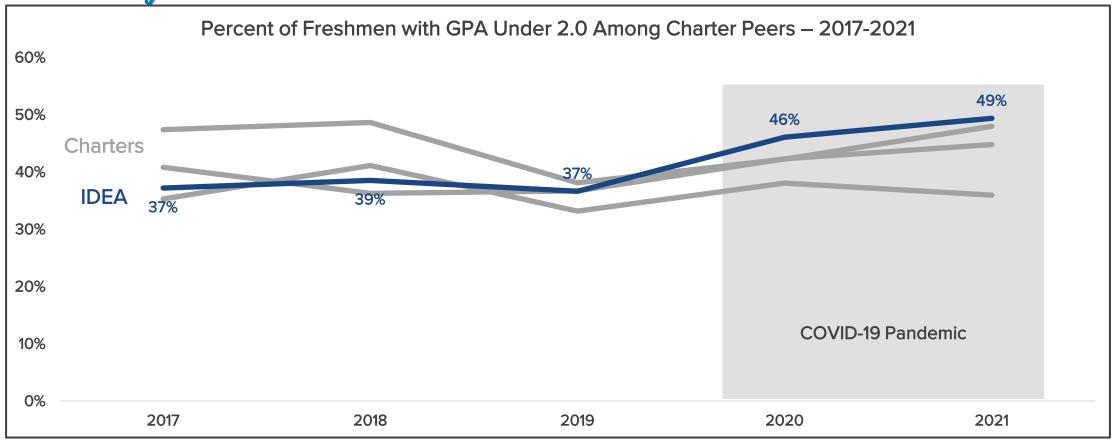

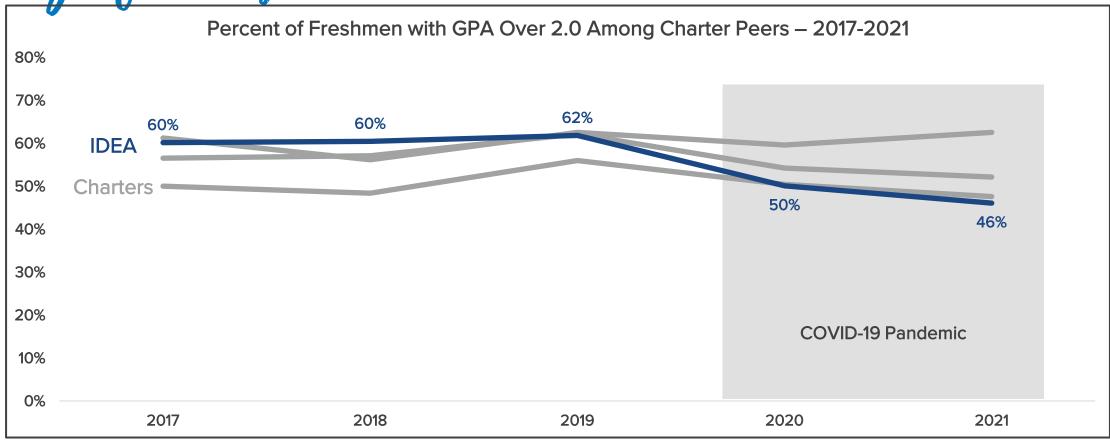

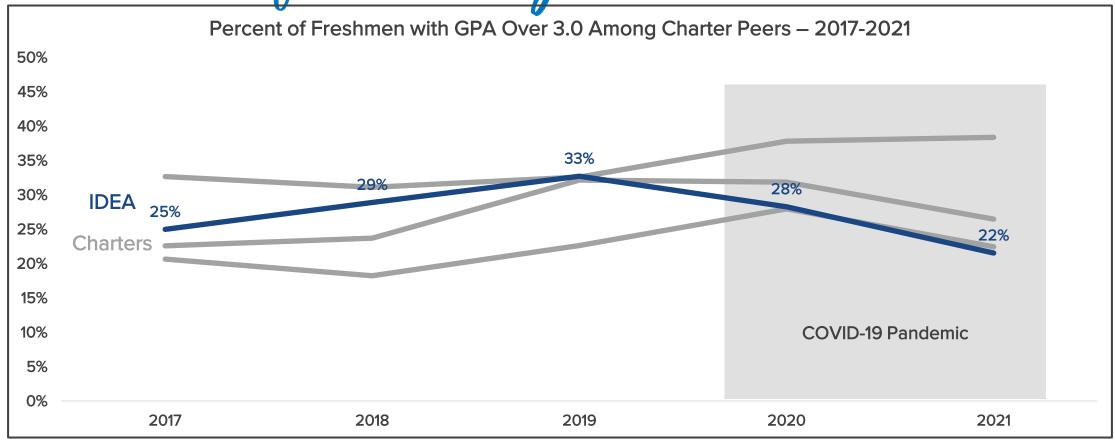

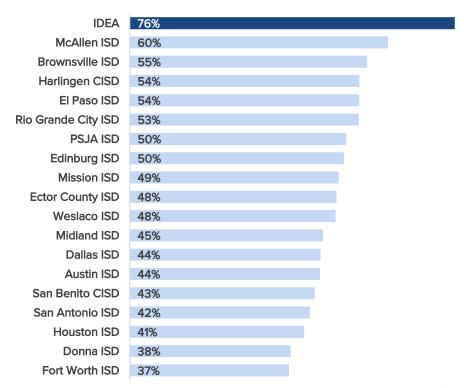

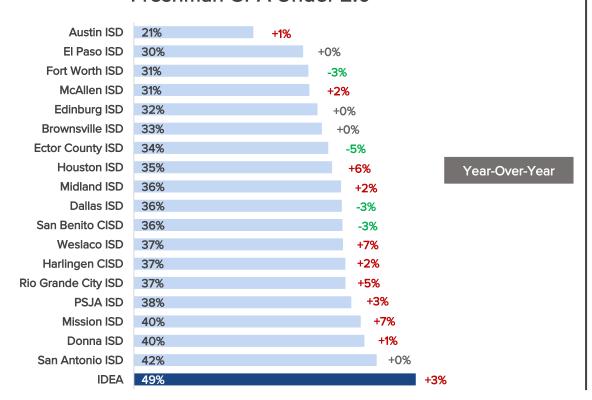

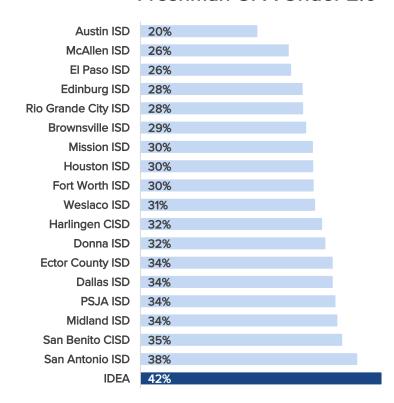

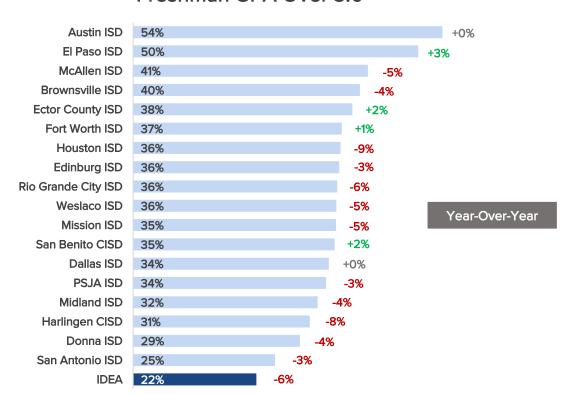

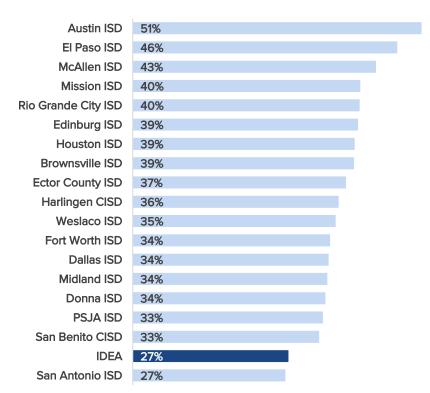

- Campus Performance Objectives TEC, §11.253, requires each campus to have an improvement plan with performance objectives and to measure progress toward meeting these objectives.
- Both the objectives of each campus and each campus' progress toward meeting those objectives must be included in the district's annual report.
- Schools are updating their progress as part of their quarterly Progress
 Towards Goals meetings
- Reports are attached and posted on our website for public review
- All campus improvement plans include HB3 performance objectives (3rd grade reading & math and CCMR)
- CIP goals are aligned to district goals



Campus Improvement Plan Outline

There are four required components of a Campus Improvement Plan that are essential to effective implementation and the needs assessment is the foundation:

- 1. Conducting a Comprehensive Needs Assessment
- 2. Preparing an Improvement Plan, and
- 3. Connecting the CIP to the budget
- 4. Reviewing and revising every quarter

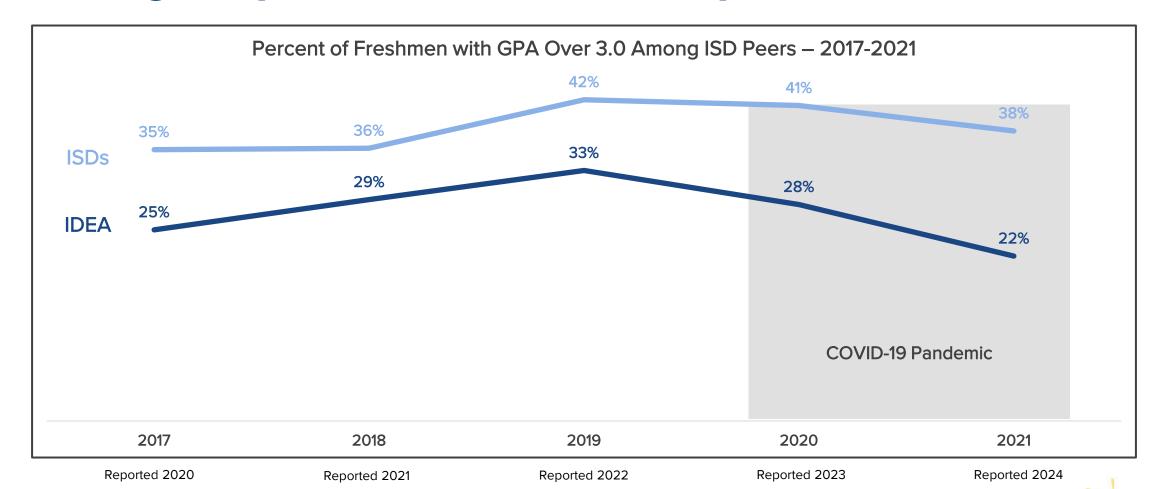

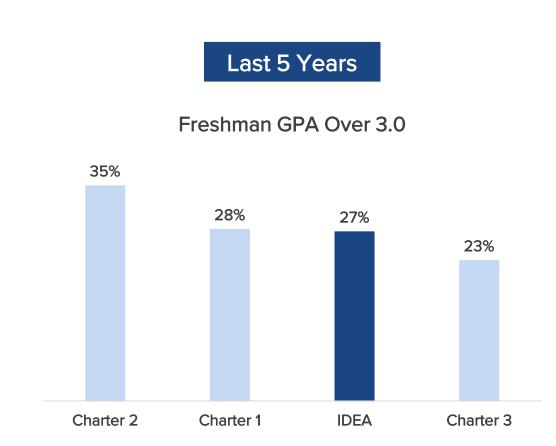

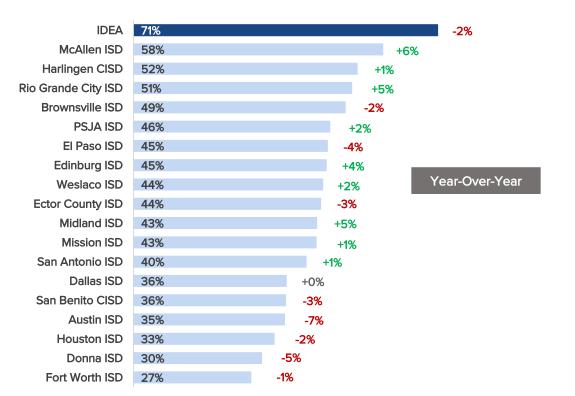

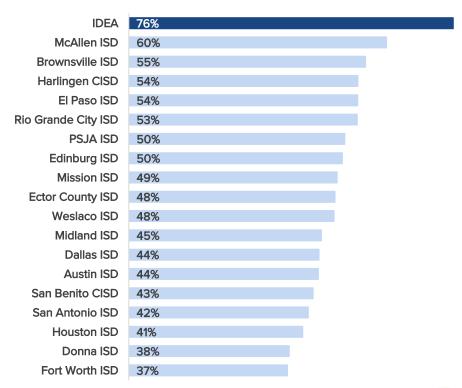

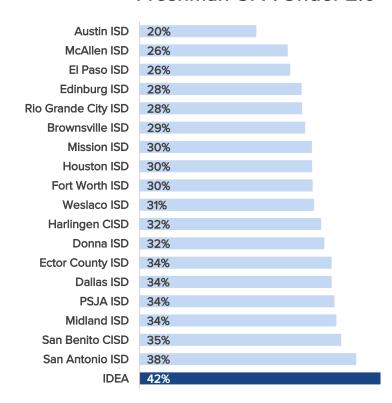

Freshman GPA Under 2.0



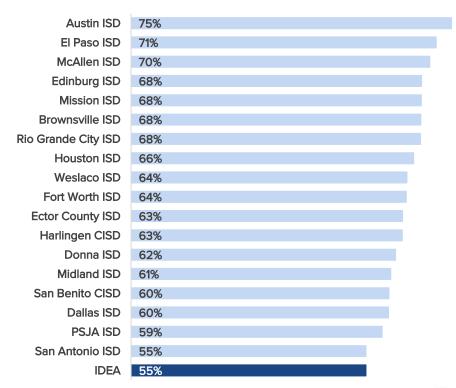

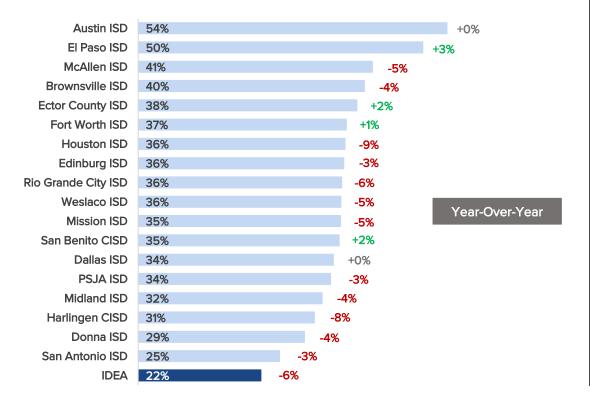
