IDEA Public Schools Offers Free Meals through Community Eligibility Provision

IDEA schools across the state to offer free breakfast and lunch to students during school day

Jacksonville, FL (July 22, 2026) – [IDEA Public Schools](#) is excited to announce it will be implementing the Community Eligibility Provision (CEP) under the National School Lunch and Breakfast Programs for the upcoming 2026-27 school year. All IDEA Jacksonville schools will provide nutritious breakfast and lunch to all children at no charge. This will eliminate the collection of meal applications for free, reduced-price, and paid student meals.

“When students have access to nutritious meals, they’re better equipped to learn, grow, and succeed both in and out of the classroom,” said Janine Valentin, Vice President of Operations for IDEA Florida. “Through the Community Eligibility Provision, IDEA is proud to provide every student with healthy, balanced meals at no cost to families, helping ensure they have the nourishment they need to thrive every school day.”

No action is required from families for their child(ren) to participate in the free meal offerings.
